On September 14, 2012, the distributed generation working group¹ ("Working Group") issued its final report, Proposed Changes to the Uniform Standards for Interconnecting Distributed Generation in Massachusetts ("Report") and submitted it to the Department of Public Utilities ("Department"). The Report contains many recommendations for changes in the Uniform Standards for Interconnection Standards for Distributed Generation ("Tariff") and additional recommendations that do not fall squarely within the Tariff. On October 24, 2012, the Department held a technical conference the Report. On October 31, the Working Group filed with the Department its recommended changes to the Tariff ("Redlined Tariff"). On November 26, 2012, the Department requested comments on both the Report and the Redlined Tariff. On December 7, 2012, the Department received comments from the Working Group, Cape Air, the Interstate Renewable Energy Council, the Solar Energy Industries Association, the Attorney General of the Commonwealth of Massachusetts, and joint comments from

On January 23, 2012, the Department convened the Working Group and tasked it with (1) determining what issues should be resolved regarding the current distributed generation interconnection standards and application procedure to ensure an efficient and effective interconnection process; and (2) deliberating with the goal, to the extent possible, of reaching a consensus on a resolution of such issues for Department review and approval.
